The Coastal Community Foundation of South Carolina addresses community needs in the region by providing grants to nonprofit organizations in the following coastal counties of South Carolina:

The Foundation administers the following competitive grantmaking programs:

#### The Blackbaud Fund

Grants of up to \$10,000 are available to nonprofit organizations in Berkeley, Charleston, and Dorchester counties serving disadvantaged or minority youth by providing educational opportunities.

### Charles Webb/Ed Croft Endowment

Grants of up to \$10,000 are available for nonprofit organizations in Berkeley, Charleston, and Dorchester counties serving children with special needs.

### • Cooper River Bridge Run Fund

Grants of up to \$1,500 are available for nonprofit organizations in Berkeley, Charleston, and Dorchester counties that promote regular physical activity for a healthy lifestyle.

### DonorsChoose/Teacher Mini Grants

This program seeks to increase funding for teacher-initiated classroom projects. Educators throughout South Carolina can post proposals on the DonorsChoose website, so donors can fund those they find most appealing.

### • Griffith/Reyburn Lowcountry Artist of the Year Award

One award of \$6,000 made annually to a visual artist who is a resident of Charleston County for the creation of a work of art that reflects or depicts "the look and feel" of the Lowcountry.

### The N.E.W. Fund (Neighborhoods Energized to Win)

Grants of up to \$3,000 are available to low- or moderate-income neighborhood groups in Charleston and Colleton counties. The grants are used to address key issues in the neighborhoods and to strengthen the leadership skills of neighborhood residents.

# Volvo Car USA Operations Grants Fund

Grants ranging from \$1,000 to \$25,000 are provided to nonprofit organizations that serve the community surrounding the Volvo factory site.

### REALTORS Housing Opportunities Fund

Grants up to \$5,000 are provided to nonprofit groups in Berkeley, Charleston, and Dorchester Counties that focus on affordable housing, including education, development, maintenance, or repair.

#### Social Venture Partners Charleston

Grants are provided to nonprofit organizations addressing education, health, and workforce development.

### The Winthrop Family Fund

Grants of up to \$5,000 are available to nonprofit organizations in Allendale and Hampton counties addressing all charitable areas, with emphasis on education, health, and conservation/preservation of the built and natural environment.

### Regional Grant Cycle (The Beaufort Fund)

Nonprofit organizations working in Beaufort, Berkeley, Charleston, Colleton, Dorchester, Hampton, and Jasper counties, as well as arts organizations in Georgetown County, are eligible to apply for funding during the Regional Grant Cycle.

### **Areas of Interest:**

The Denver Foundation is dedicated to enhancing the quality of life in the metropolitan Denver, CO, area, including Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, and Jefferson counties.

The Foundation provides support through the Community Grants program, which supports organizations and projects that reduce racial, ethnic, and economic disparities in the following areas:

- Basic Human Needs
  - The focus is on improving the lives of those experiencing hunger, homelessness, domestic violence, and lack of access to basic medical care.
- Leadership and Equity

The focus is on building a diverse pool of leaders to increase racial equity.

Economic Opportunity

The focus is on improving the economic health of people and communities facing the biggest barriers to economic equity, including job training and economic justice. Support is also provided for organizing, advocacy, and policy reform work.

#### Education

The focus is on increasing school readiness for young children and student engagement and academic achievement for pre-K-12 students. Interests include early childhood education and arts education.

#### Arts

The focus is on arts organizations and projects that connect directly to employment and economic development and art projects that support school readiness, student engagement, and academic achievement.

All of the Foundation's work focuses on people living in poverty, immigrants and refugees, and people of color.

Types of support include general operating support and funding for specific programs and projects.

Note: The Foundation's Strengthening Neighborhoods program provides Community Grants to residentled projects that reduce racial, ethnic, and economic disparities and that fit within the priority areas listed above. Emphasis is given to low-income communities of color.

The Foundation also administers the following funds and programs:

- Technical Assistance Grants;
- Bowen Family Performing Arts Fund;
- Rollie R. Kelley Family Foundation Fund, with a focus on inner-city ministries, improving the cultural quality of life, economic education, youth and families at risk, and children's mental and physical health;
- Comprecare Fund, with a focus on wellness for seniors;
- Colorado Health Access Fund;
- DESCI Community Housing Program;
- Environmental Affinity Group;
- Colorado Nonprofit Loan Fund;
- The Greenwood Fund, with a focus on museums;
- Social Venture Partners Denver (there is a separate GrantStation profile for this program);
- The Eulipions Fund, with a focus on African-American performing arts;
- Transforming Safety, with a focus on crime prevention;
- the Xcel Energy Renewable Energy Trust (RET), with a focus on renewable energy projects; and,
- Lauren Townsend Memorial Wildlife Fund.
