## **Areas of Interest:**

The Community Foundation of Greater Flint serves the common good in Genesee County, MI, by building a strong community by engaging people in philanthropy and developing the community's permanent endowment.

Each year, the Foundation awards grants to nonprofit organizations, educational institutions, and government agencies through a competitive grantmaking process.

Currently, the Foundation's competitive grantmaking priorities include:

- literacy;
- Flint neighborhoods; and,
- access to healthy food.

Grants are also made through field of interest funds focusing on:

- health, including maternal, infant, and children's health; mental health; and end of life care;
- youth;
- beautification and historic preservation; and,
- women and girls.

Collaborative efforts are encouraged.

Grants for sectarian religious purposes or any religious activities are not eligible. Grants are not made for loans, debt reduction, or annual appeals.

The Foundation also provides support through the following programs:

### Neighborhoods Small Grants Program

This program puts resources into the hands of small grassroots community groups, empowering people to become actively engaged in the health and well-being of their community. The focus is on projects that:

- strengthen neighborhood groups;
- create safe environments;
- improve neighborhood conditions; or,
- create opportunities for neighbors to connect to each other and to resources.

Grants range from a few hundred dollars to \$25,000.

### Flint Kids Fund

This fund is focused on mitigating the impact of the Flint water crisis on children. The Fund makes grants for programs that:

- improve access to a medical home and a child health team for all children and pregnant mothers, to ensure in part that all children are provided with robust developmental assessments and support; and,
- increase family, social, and emotional support.

## Flint Women and Girls Fund

The purpose of this fund is to encourage the advancement and full participation of women and girls in society by promoting the removal of barriers to their economic, educational, physical, emotional, social, artistic, and personal growth. The focus is on:

- supporting programs that advocate policy and system change on issues that affect women and girls;
- encouraging programs that will enable women and women's organizations to achieve economic self-sufficiency;
- supporting organizations which increase the range of choices available to women and girls; and,
- giving high priority to organizations in which women are the primary decisionmakers.

#### **Youth Advisory Committees**

These committees (Clio, Countywide, Grand Blanc, and South Lakes) are groups of students from local high schools who are responsible for reviewing funding requests and recommending grants for programs that benefit Genesee County youth.

In addition, The Foundation currently works with five communities that have established endowed funds to provide a permanent source of funding to enhance the quality of life for the citizens of these communities. The Foundation's five community funds are:

• Clio Area Community Fund;

Flushing Community Fund; and,

Davison Community Fund;

• Grand Blanc Community Fund.

Fenton Community Fund;

Education: Letters of inquiry are accepted from September 1 to September 30, annually. Human Services: Letters of inquiry are accepted from December 15 to January 15, annually.

Health: Letters of inquiry are accepted from April 15 to May 15, annually.

#### **Areas of Interest:**

The mission of the Crail-Johnson Foundation is to promote the well-being of children in need through the effective application of human and financial resources. The Foundation primarily supports nonprofit organizations benefiting children, youth, and families in the greater Los Angeles, CA, area.

National organizations providing services in Los Angeles are also considered. Occasionally, grants are made to programs and projects that are regional or national in scope, where potential benefits to children and families in Los Angeles can be clearly demonstrated.

The Foundation's current areas of emphasis include the following:

#### **Human Services**

Interests include the following:

- Child Abuse and Domestic Violence Prevention and Treatment Support is given to efforts directed toward the prevention and treatment of family violence, including community and educational outreach, counseling, and shelter services.
- Food Banks, Food Pantries, and Food Distribution
   Support is given to efforts directed toward the collection and distribution of food to relieve hunger in communities.

#### Homeless Services

Support is given to organizations providing assistance to homeless children, youth, or their families, including temporary, short-term, or long-term housing, and programs to assist families with job skills, nutritional education, housing security, and parenting skills, among others.

Youth Development and Enrichment
 Support is given to programs which serve to continue and improve foster care services, juvenile crime prevention and diversion, mentoring, camp activities, recreation, and specific populations, in particular developmentally and physically challenged children and youth.

#### **Education**

Interests include the following:

- Early Care and Education
  - Support is given to programs that address the health, academic, and social/emotional needs of children preparing to enter kindergarten.
- Literacy

Support is given to programs that focus on bringing children to grade level in reading and literature.

- Arts Education
  - Support is given to programs that provide high-quality arts education that engages children and youth in a variety of art forms including, but not limited to, music, theater, dance, and film.
- Parent Engagement and Education
  - Support is given to programs that provide education to parents on how to create a positive environment for their children both at home and at school, and increase participation, communication, and collaboration between parents, schools, and communities with the goal of educating the whole child to ensure student achievement and success.
- STEM Curriculum

Support is given to science, technology, engineering, and math programs which serve to build skills in math and science at the elementary, middle, and high school levels, in addition to programs which increase awareness of science concepts and applications.

Youth Development
 Support is given to tutoring, mentoring, computer, and other educational enrichment programs, which enhance self-esteem, promote the value of education, and improve educational outcomes.

#### Health

Interests include community health, with a focus on whole person/whole family health, and overall goals to improve access to care, provide education, screening, and treatment, and improve health outcomes; mental health and wellbeing, especially for students, the homeless, and unhoused, and special needs individuals and their caregivers/families; direct medical services, (especially pediatric care) provided at community clinics/federally qualified health centers) and school-based health centers; and dental care.

Support is exclusively focused on programs that address the needs of economically, socially, and physically disadvantaged children. The Foundation supports both proven approaches and innovative programs aimed at systemic change, and provides support for new, continuing, or expanding programs. Programs and services may be school-based, school-linked, or other community-based places. Funding priority is currently given to initiating, continuing, or expanding programs.

Types of support also include general operating support and capital projects, as well as selected endowments. The Foundation also provides technical assistance to selected community-based initiatives benefiting children and families.

Support is not granted to/for:

- programs and projects benefiting religious purposes;
- university-level education;
- research;
- events recognizing individuals or organizations;
- political causes;
- programs attempting to influence legislation; or,
- individuals.
